- 01. Bidding will be conducted through National Competitive Bidding (NCB).
- 02. Multiple options/Alternatives shall not be allowed.
- 03.Bidders may obtain site visit, further information and inspect the bidding documents at the supplies division of the University from 9.00 a.m. to 3.00 p.m. on any working days until 01st September 2025.
- 04. Bidders shall have valid business registration along with the experience in supplying Acoustic Solutions in Industrial Level. Necessary evidence and documents shall be submitted to fulfill aforementioned requirements. Other additional requirements are included in the bidding document.
- 05. A complete set of bidding documents in English Language may be purchased by interested bidders on the submission of a written request to the address below, from 11th August 2025 to 01st September 2025 from 9.00 a.m. to 2.00 p.m. on working days, and upon payment of a non-refundable fee of Rs. 12,500 (Rupees of Twelve Thousand Five Hundred) for document. The payment will be made in cash to the shroff of this University.
- 06. Pre Bid meeting will be held at 10.00 a.m. on 22nd August 2025 in the Faculty Board Room, of the University.
- 07. Sealed bids in duplicate may either be sent by registered post addressed to the Chairman, Department Procurement Committee of the University of Vocational Technology, No.100, Kandawala Road, Ratmalana or deposited in the tender box kept at the supplies division of the University receive before 2.00 p.m. of 02nd September 2025 "Procurement No, Details of the procurement and the date of opening of bids" (2.00 p.m. 02nd September 2025) should be mentioned on the left hand top corner of the envelop containing the bid. Bids received late will be rejected.
- 08. All bids shall be accompanied by a Bid security obtained from any Commercial Bank approved by the Central Bank of Sri Lanka. The amount of the Bid security is stated in the above table, valid until four months from the date of Bids opening and it should be obtained in favour to the Vice Chancellor, University of Vocational Technology.
- 09. Valid Certificate of Registration obtained from the Register of Public Contract, as prescribed in Public Contract Act, No.3 of 1987, if the contract exceeds **five million rupees.**
- 10. The selected supplier's solution should comply with the standards and specifications given by the Industrial Technology Institute (ITI). The supplier needs to obtain an Industrial Technology Institute (ITI) compliance report before handing over the project.
